- Please pay in full before your guests begin to arrive. We accept cash, check & debit/credit.
- Limit of 60 bowlers/80 attendees
- No street shoes beyond the entrance. Bowling shoes must be worn by all bowlers.
- No food or drink permitted on lower level of the facility
- We ask that you remain in control of your guests at all times. Minors **MUST** be supervised. Anyone acting inappropriately will be asked to leave the premises.
- Please be aware you are liable for any damage to BSL equipment/property that may occur during your rental. We reserve the right to bill you and/or keep your deposit should any damages/issues arise
- If you need to cancel your event, your \$50 deposit check will **NOT** be returned, however we will gladly reschedule at no cost/penalty with at least two weeks prior notice to original date.
